Note: The annual maximum loan payment amount for a recipient is \$4,000 or the outstanding balance of student loan debt verified by the lender, whichever is less. Eligible recipients may receive a maximum of \$20,000 over no more than 5 years and not exceeding \$4,000 per year. All loan payments are disbursed directly to the lender of the eligible student loan.
